FFY 2023 thru FFY 2025 DBE Goal and Methodology

Overall Goal

The Kingsport Area Transit Service (KATS) has completed its goal setting and methodology report for its three year Disadvantaged Business Enterprise (DBE) overall goal applicable to Federal Fiscal Years (FFY) 2023, 2024, and 2025 October 1, 2023 through September 30, 2025 contracting opportunities funded in whole or in part by the Federal Transit Administration (FTA), exclusive of FTA funds to be used for the purchase of transit vehicles.

KATS proposed DBE overall goal will be 1.4%. KATS overall goal is based on demonstrable evidence of the availability of ready, willing and able DBEs relative to all business ready, willing and able to participate in KATS's DOT-assisted contracts. It reflects the level of DBE participation that KATS would expect absent the effects of discrimination. **KATS's entire 1.4% goal will be obtained through race-neutral means and 0% through race-conscious means.**

In order to establish its overall DBE goal, KATS followed federal regulations, including the two-step goal-setting methodology set forth in 49 CFR Part 26.45. KATS determined a "step one" base figure for its overall DBE goal using information from the Tennessee DBE Unified Certification Program (UCP) Directory (Attachment 1) as well as from the data densus.gov website (Attachment 2). KATS also determined which NAICS codes would be relevant by researching on the NAICS Identification Tools website. KATS determined whether a "step two" adjustment was needed.

Defined local Market Area: KATS used the Tri Cities area in order to define a local market area. This area consists of the following counties in Tennessee: Sullivan, Hawkins, and Washington. Based on areas we have done business with in the past and anticipate future business needs, these surrounding counties have been selected.

Basic Requirement: To begin the goal setting process, the recipient must first develop a base figure for the relative availability of DBEs. To determine a base figure for the relative availability of DBEs in the Kingsport Area Transit Service defined market area, the current TNUCP state-wide Disadvantaged Business Enterprise Directory (Attachment 1) was used as the numerator. The U.S. Census Bureau found on data.census.gov (Attachment 2) data for Sullivan County, Washington, and Hawkins was divided by the total number of all firms in Sullivan, Washington, and Hawkins counties listed in the Census Bureau with relevant NAICS codes (also Attachment 2) for the types of services utilized by KATS for transit system operations. After the base

figure was achieved, all other relative evidence was considered to see if an adjustment of this figure was needed to match the needs of the specific DBE community.

Projections

KATS projects that it will receive \$ 3,900,000 in FTA financial assistance during FFYs 2023, 2024, and 2025. That projection is based on the grants and financial assistance that KATS received and was awarded. Out of that figure, KATS estimates that FTA's contractible portion would be approximately \$833,371. See table below of future projected money spread out over FFY 23, 24, and 25.


KATS 2023-2025 DBE proposed goal was published in the *Kingsport Times News* (the only local daily newspaper) on June 22, 2022 and was allowed a thirty (30) day public comment period. A copy of the newspaper affidavit of publication is shown in Attachment 6. KATS' proposed goal is also available to the public on the KATS website at www.kingsporttransit.org.

In addition to the above public outreach regarding KATS' proposed DBE goal, KATS staff made extensive effort to consult with area officials or organizations which might have information concerning the availability of disadvantaged and non-disadvantaged businesses and the effects of discrimination on opportunities for DBEs. KATS' efforts to establish a level playing field for the participation of DBEs was also part of this effort in goal development. Additional outreach efforts included posting information about DBE and goal setting on Facebook, the KATS website, and in the KATS lobby. KATS also hosted a DBE public information meeting with neighboring transit agency Johnson City Transit, and has attended several online educational workshops regarding DBE. We are

working with local DBE vendors and have continual outreach to KOSBE (Kingsport Office of Small Business Development and Entrepreneurship) with the Chamber of Commerce regarding goal setting.

DBE Public Outreach Opportunity

On April 5, 2022 from at 9:30, KATS and Johnson City Transit hosed a DBE Public Informational meeting at City Hall in Kingsport, TN located at 415 Broad Street. The meeting was advertised in the Kingsport Times News, the Johnson City Press as well as Facebook and on the KATS and JCT website. Transit Planners Candace Sherer and Bradley Osbourne hosted the meeting. This was an informational meeting intended to to share and collect information regarding DBE participation. (see attached meeting slides as well as attachment 4). I was able to describe what KATS does and to describe the kind of opportunities that would be coming available for contractors and subcontractors. I explained that we had a DBE goal that was developed specifically for our agency and how we are to strive to meet that goal. The program specifically addressed how to become a DBE as well as the advantages.

KATS is continuously keeping current via webinars or workshops. I attended a 4 day National Transit Institute DBE training on May 16-19, 2022. This training was in compliance with DOT's DBE regulations. The course involved the application and administration of the DBE requirements so that agencies can have a complete understanding of these requirements and engage in the best practices with regard to encouraging participation by DBE's. I also attended an online workshop on May 17th with TSBDC at East Tennessee State University on how to become DBE certified. I attended a TDOT DBE Procurement Training via Teams on May 25, 2022. Webinars such as this assist in continued education on how to set the DBE goal and the methodology. These webinars allow for live questions as well as several documents available for downloading which provide vital information and examples as well as names and contact information for further assistance if needed. KATS is subscribed to newsletters such as "Minority Business Development Agency Digest Bulletin" and receives TNUCP updates through the Tennessee Department of Transportation.


DBE Public Outreach Ongoing Efforts

KATS has an ongoing relationship Aundrea Wilcox who is the Executive Director of KOSBE (Kingsport Office of Small Business Development & Entrepreneurship). KOSBE is located at 400 Clinchfield Street and is a part of the local City of Kingsport Chamber of Commerce. The relationship here allows Aundrea to inform anyone she comes in contact with who is interested in DBE what about the transit field and what opportunities that they might know of for DBE companies to be able to do business with our agencies. Aundrea Wilcox is willing to work with any interested businesses that need assistance in becoming DBE certified for the area. She is she interested in helping people become DBE certified, but she also wants to see them grow and be successful as a company. KATS is on the email mailing list for DBE activities and opportunities to continue their education. Transit Planner, Candace Sherer keeps in contact with Aundrea regarding DBE business so that she can continue in public outreach to try to increase awareness in the community for DBE participation.





In accordance with the requirements of the U.S. Department of Transportation as set forth in 49 C.F.R. Part 26, as amended, the Kingsport Area Transit Service (KATS) hereby notifies the public that it is recommending a Disadvantaged Business Enterprise (DBE) goal of 1.4% of Federal financial assistance expended in DOT-assisted contracts, (exclusive of FTA funds to be used for the purchase of transit vehicles). KATS plans to obtain this goal through race-neutral means. The overall goal is based on the availability of ready, willing, and able DBE firms verses all business ready, willing, and able to participate in KATS DOT assisted contracts.

The proposed goal and the methodology plan are available for review between 8:00 a.m. and 5:00 p.m., Monday through Friday at 900 East main Street, Kingsport, TN 37660. It is also available online at **www.kingsporttransit.org**. Written comments on this goal will be accepted for 30 days, from June 22, 2022 through July 22, 2022. The comments are for information purposes only and may be sent to the KATS's DBE Staff, Candace Sherer or via email at **www.kingsporttransit.org** in the contact section. Methodology Used to Calculate Overall Goal

Step 1: 26.45 (c)

Determine the base figure for the relative availability of DBEs.

The data source or demonstrable evidence used to derive the numerator was: TDOT website for TN DBE UCP codes which is updated regularly (2022 version). The data source or demonstrable evidence used to derive the denominator was: data.census.gov.

KATS determined relevant DBE vendors in our region by looking on the TDOT website and looking at the TNUCP certified listings. (See attachment 1). We also identified DBE vendors that we have used in the past and are currently using for continued yearly projects. KATS also researched the Census Bureau Data by NAICS codes (Attachment 3). The total number of relevant DBE firms (3) in the TDOT database for TDOT Region 1 of TN within the counties surrounding the Tri Cities area including (Hawkins, Sullivan, and Washington) where KATS is located was divided by the total number of firms listed by the data.census.gov. (See attachment 2) for the Region 1 above defined market area within these same counties (264) firms that provide goods and services utilized or possible forecast of utilizing by KATS for transit system needs.

This calculation resulted in 3 relevant DBEs (Region 1 TDOT DBE List with applicable NAICS codes) divided by 221 firms with applicable NAICS codes for projected work equals 0. 01357 or a **base goal of 1.4 percent**.

Step Two 26.45 (d): Are Adjustments to Base Figure Needed? (Part 26.45 (d))

KATS has examined all of the evidence available in KATS' jurisdiction to determine what adjustment, if any, is needed to the base figure in order to arrive at its overall goal. No disparity studies are available for the KATS area, but based on:

KATS desire is to support opportunities for DBE's to form, grow, and compete in this Area, such as self-employment, education, marketing, and training.

The low number of DBE vendors in the TDOT Region 1 area, specifically in our determined market area with specific NAICS codes (a total of 3) found in TNUCP state-wide directory of Certified DBE Vendors for Hawkins, Sullivan and Washington counties.

Past participation is not a deciding factor; however, if KATS has experienced a mutually successful experience on projects or services rendered, the DBE would then be considered again for projects is FFY2023-2025. There are a couple of vendors on the UCP list that we have contacted in our area that after discussion, we realized did not provide the service needed. KATS does somewhat factor in the fact that this is not an area with great DBE sources. This fact can make meeting the DBE goal challenging despite the fact KATS continues to try and grow this market.

Weighting

In order to determine the weight, each projected amount to be spent on each NAICS code description was divided by \$ 833,371. This figure was determined by summarizing the FTA contractible funds available to be spent on operations \$466,200, the projected fuel cost of \$127,171, \$90,000 on an Operations Study and a new dispatch software program was \$150,000. These figures added together amounted to \$833,371.00. This is how the calculations were determined.

Weight of each type of work by NAICS Code:

All FTA-assisted projects below: Project amounts assigned relevant NAICS Code (s).

\$833,371 will be allocated from FTA assisted funding. As identified in the table below (Attachment 1), the relative availability of DBE contractors in the market area is very limited.

(Weight) X (Availability) = Weighted Base Figure

Weighted Base Figure: .1.19%

The formula resulted in no adjustment to the goal.

Based on the limited availability of DBE firms in our area, the current projected scope of work, and the weighted figure of 1.19 %, KATS believes that a 1.4% goal is a fair goal at this time. (1.4 % + 1.19% = 2.59 / 2 = 1.3). We have set our DBE goal at 1.4 percent with the expectation to review this goal as needed in accordance with project variance.



What is DBE all about?

Disadvantaged Business Enterprise (DBE) Program

It is the policy of KATS (Kingsport Area Transit Service) to afford Disadvantaged Business Enterprises (DBEs), as defined in 49 CFR Part 26, as amended, the maximum opportunity to participate in the performance of contracts financed in whole or in part with federal funds. KATS DBE Policy Statement may be viewed by visiting our website at <u>www.kingsporttransit.org</u>.

Definitions of DBE = Disadvantaged Business Enterprise

Eligibility Guidelines (in general):

Ownership- Your business must be 51% owned by a socially and economically disadvantaged individual(s).

"Disadvantaged"- You may be eligible if you are a member of a group of persons the Department considers as disadvantaged. The Department presumes certain groups are disadvantaged, including women, Black Americans, Hispanic Americans, Native Americans, Asian-Pacific Americans, Subcontinent Asian-Pacific Americans, or other minorities found to be disadvantaged by the U.S. Small Business Administration (SBA). Persons who are not members of one of the above groups and own and control their business may also be eligible if they establish their "social" and "economic" disadvantage. The Department notes, for example, that people with disabilities have disproportionately low incomes and high rates of unemployment, and that many may be socially and economically disadvantaged. A determination of whether an individual with a disability meets DBE eligibility criteria is made on a case-by-case basis. More information on how social and economic disadvantage is determined can be found in <u>Appendix E to 49 CFR Part 26</u>.

- Business Size Determination- A firm (including its affiliates) must be a small business as defined by SBA standards. It must not have annual gross receipts over \$28,480,000 in the previous three fiscal years (\$52,470,000 for airport concessionaires in general with some exceptions). Under MAP-21, this threshold will be adjusted annually for inflation by the Secretary.
- Personal Net Worth- Only disadvantaged persons having a personal net worth of less than \$1.32 million can be considered as a potential qualified DBE. Items excluded from a person's net worth calculation include an individual's ownership interest in the applicant firm, and his or her equity in their primary residence.
- Independence- Only an independent business may be certified as a DBE. An independent business is one the viability of which does not depend on its relationship with another firm or firms.
- Control- A disadvantaged owner seeking certification must possess the power to direct or cause the direction of the management and policies of the firm. The owner must also have an overall understanding of, and managerial and technical competence and experience directly related to, the type of business in which the firm is engaged.
- **Burden of Proof Allocation** Applicants carry the initial burden of proof regarding their eligibility and must demonstrate that they meet all requirements concerning group membership or individual disadvantage, business size, ownership, and control.

What is a DBE?

A DBE is a for-profit small business that is at least 51 percent owned and controlled by one or more individuals who are both socially and economically disadvantaged, as defined in 49 CFR Part 26. For a link to DBE regulations, 49 CFR Part 26, visit kingsporttransit.org.

How does a business become certified as a DBE?

KATS DBE certification is administered by the Small Business Development Program, Civil Rights Office, Tennessee Department of Transportation (TDOT). Once a business is certified as a DBE, the Tennessee Unified Certified Program allows multiple agencies to utilize the same certification statewide, to simplify the application process.

Obtaining Certification

Firms meeting the eligibility standards must contact the specific state or local transportation entity for which they wish to participate in contracts. In addition to requesting documentary evidence substantiating a firm's size, owner's PNW, independence, and an individual's ownership and control, recipients are required to perform an on-site visit to the firm's offices and job sites. Firms can obtain instructions on how to apply to become a DBE by contacting <u>state departments of transportation</u> or <u>state DBE liaison and certification officers</u>. To ease the burden of applying to multiple DOT recipients within a state, the Department requires a Unified Certification Program (UCP) to be developed so that applicants need only apply once for DBE certification that will be honored by all recipients in the state.

In response to longstanding concerns of DBEs, the Department instituted measures effective January 1, 2012, designed to make the certification process easier on recipients and certified DBEs. The measure found in 49 C.F.R. Part 26, <u>§26.85</u> prescribes how certifiers are to process requests for certification from DBE firms certified in other jurisdictions. Firms must be certified in their home state before seeking certification in another state under the rule.

Uniform Certification Application

The Unified Certification Program (UCP) allows applicants for the Disadvantaged Business Enterprise (DBE) program to apply only once for a DBE certification that will be honored by all recipients in the state. Be advised that the <u>U.S Department of</u> <u>Transportation</u> does not review DBE applications. If you have questions about where to send your DBE application package, please contact the state transportation agency in the state in which you want to apply for. For your reference, we maintain a list of <u>DBE</u> <u>program points of contacts</u> and <u>websites</u>. All applicants to the DBE/ACDBE programs must submit a complete application package to a Unified Certification Program (UCP) member agency in the applicant's home state. What are the advantages of being certified as a DBE?

Certification as a DBE provides greater exposure for contract opportunities. Upon being certified as a DBE, your business's address is added to a state-wide database which is compiled and maintained by TDOT. This list, the TDOT Certified Disadvantaged Business Enterprise Listing, is accessed by other transit systems, as well as municipal and state agencies seeking to do business with DBEs. Being certified as a DBE enhances a business's exposure to the business community. However, there is no requirement to be a certified DBE in order to do business with KATS. The current TDOT Certified Disadvantaged Business Enterprise Listings may be viewed by visiting Kingsport Area Transit Service or using the direct link https://www.tdot.tn.gov/APPLICATIONS/DBEDirect/.

Once approved an interview took place. A representative came to my residence to interview me and inspect my equipment.
